3. How We Use Your Data

- Ensuring safe treatments based on allergies or medical conditions
- Internal training and quality assurance

4. How We Store and Protect Your Data

• Data is stored securely on trusted platforms like Wix, Stripe, and Revolut.

- Paper files (e.g., patch test forms) are stored in locked files on-site.
- We implement secure passwords, device protections, and limited staff access.
- Sensitive data is only kept for as long as legally necessary.

5. Marketing & Communication Preferences

- You will only receive marketing emails if you **explicitly opt-in** via our Wix form or purchase form.
- You may unsubscribe at any time by clicking the link in any email or contacting us directly.
- WhatsApp or SMS communications are used for customer support, reminders, and student updates.

6. Sharing Your Data

We do **not sell or rent** your data.

We only share data with:

- Payment processors (e.g., Stripe, Klarna, Revolut)
- Wix (website + email platform)
- WhatsApp (client communication)
- Courier services (for product delivery)

All third-party providers we use are GDPR-compliant.

7. Cookies & Website Tracking

Our website uses:

- Cookies to help it function and remember preferences
- Google Analytics and Wix Analytics to understand visitor behavior
- Facebook Pixel for ad tracking and marketing
